Pursuant to § 61-4-101 and 61-12-901, MCA any applicant for a new dealer's license, a used dealer's license, a broker's license, an auto auction license, a wholesaler license, or a manufactured home license shall submit a written application to the department. The application must be signed by the applicant and contain a verification by the applicant, under penalty of law, that the information contained in the application is true and correct. Any information provided in the license application process is subject to independent verification by the department or an authorized representative of the department.

After examining a license application and conducting an investigation necessary to verify the information contained in the application and if the department is satisfied that the applicant qualifies for the issuance of a license under the provisions of this chapter, the department may issue the license. The department may refuse, after examination and investigation, to issue a license to an applicant who is not qualified for licensure or whose prior financial or other activities or criminal record, as determined by the department:

- (i) poses a threat to the effective regulation of dealers, wholesalers, or auto auctions;
- (ii) poses a threat to the public interest of the state; or
- (iii) creates a danger of illegal or deceptive practices being used in the conduct of the proposed dealership, wholesaler, or auto auction

CERTIFICATION AND AUTHORIZATION:

The Montana Department of Justice Motor Vehicle Division shall access and review state and federal history records and shall make reasonable efforts to determine whether you have been convicted of, or are under pending charges for, a crime that bears upon your suitability to be granted a license.

I certify under penalty of law that all answers and statements made on this application are true, correct, and complete. I understand that untruthful or misleading answers are cause for denial of a license and/or revocation of any license granted. I further understand that I may be prosecuted for knowingly making an Unsworn False Statement, a misdemeanor (§ 45-7-203, MCA), or tampering with public records or information, a felony (§ 45-7-208, MCA). I hereby authorize the Motor Vehicle Division to investigate my criminal history, financial records, and other sources as necessary for licensing.
