



Inspection Checklist for Motorcycles and Quadricycles

Every motorcycle and quadricycle that will be operated on highways or roads allowing for vehicular traffic dedicated to public use in the state of Montana must be equipped with the following as required in MCA Title 61, chapter 9. Please contact VSB for questions.

<p>1. Head Lamps – all boxes must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> 1 and not more than 2 head lamps on the front of the motorcycle <input type="checkbox"/> Positioned not more than 54 inches nor less than 24 inches from the middle of the lamps to the ground <input type="checkbox"/> High beam appears to be of such intensity to project 350 feet <input type="checkbox"/> Low beam appears to be of such intensity to project 100 feet
<p>2. Tail Lamps – all boxes must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> 1 tail lamp mounted on rear of cycle <input type="checkbox"/> Appears to be visible at least 500 feet from rear; red in color <input type="checkbox"/> Positioned not more than 72 inches nor less than 15 inches from the ground <input type="checkbox"/> Tail lamp to illuminate rear license plate; appears to be visible at least 50 feet from rear; white in color <input type="checkbox"/> Tail lamp to be lighted whenever head lamps are lighted
<p>3. Reflectors – all boxes must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> At least 1 reflector (separate or part of tail lamp) <input type="checkbox"/> Positioned not more than 60 inches nor less than 15 inches from the ground to middle of the reflector <input type="checkbox"/> Appears to be visible from a distance of 50-300 feet <input type="checkbox"/> 1 reflector mounted on cycle; red in color to rear, amber or white to front
<p>4. Stop Lamps – if equipped, all boxes must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> Stop lamp incorporated into tail lamp; red in color <input type="checkbox"/> Appears to be visible from a distance of 300 feet in normal sunlight
<p>5. Brakes – box must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> Equipped with brakes on all wheels; appear to be in good working condition; must comply with federal standards and with § 61-9, MCA.
<p>6. Horn – all boxes must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> Cannot be unreasonably loud, harsh sounding or a whistle <input type="checkbox"/> Appears to be audible from a distance of at least 200 feet <input type="checkbox"/> Constructed so as to be controlled by driver <input type="checkbox"/> Electronic
<p>7. Mufflers – both boxes must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> Muffler system to prevent excessive or unusual noise and annoying smoke <input type="checkbox"/> No fuller cut-outs, bypasses or similar devices
<p>8. Mirror – box must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> At least one mirror attached to vehicle to reflect to driver a view of the highway at least 200 ft to the rear of the vehicle
<p>9. Tires – check only ONE box – no metal tires allowed</p> <ul style="list-style-type: none"> <input type="checkbox"/> Solid rubber tires, having rubber on entire traction surface 1-inch-thick above edge of flange on the entire periphery <input type="checkbox"/> Low pressure pneumatic tires
<p>10. Minimum Speed – box must be checked</p> <ul style="list-style-type: none"> <input type="checkbox"/> Vehicles unable to travel more than 25 mph must display a slow-moving vehicle sign
<p>11. Odometer – applies to vehicles 20 years and newer, model years prior to 2011 are exempt</p> <ul style="list-style-type: none"> <input type="checkbox"/> Odometer able to record milage must be present on street legal motor vehicles subject to federal odometer requirements
